**SUBJECT : SIGNING CEREMONY ON THE MEMORANDUM OF AGREEMENT
BETWEEN THE COMMISSION ON HIGHER EDUCATION - UNIFIED
STUDENT FINANCIAL ASSISTANCE SYSTEM FOR TERTIARY
EDUCATION AND STATE UNIVERSITIES AND COLLEGES AND CHED-
RECOGNIZED LOCAL UNIVERSITIES AND COLLEGES TO AVAIL OF
BENEFITS UNDER THE UNIVERSAL ACCESS TO QUALITY TERTIARY
EDUCATION ACT (RA 10931)**

Pursuant to the mandate of the Universal Access to Quality Tertiary Education Act, otherwise known as RA 10931 directing the UniFAST Secretariat and Commission on Higher Education to facilitate the downloading of funds to State Universities and Colleges (SUCs) and CHED-recognized Local Universities and Colleges (LUCs) for the Programs under RA 10931, namely, the Free Higher Education, Tertiary Education Subsidy and National Student Loan Program, the UniFAST Secretariat is inviting you to attend the **Official Signing of the Memorandum of Agreement (MOA) between CHED - UniFAST and 112 SUCs/ 78 CHED-recognized LUCs set by the Office of the President on 11 June 2018 at the Malacañang Palace**. You will be advised of the exact time shortly by my office.

The signing of the MOA will allow the downloading of funds to the SUCs and CHED-recognized LUCs in order to avail of the benefits under RA 10931. Detailed procedures/guideline on the flow of the activity will be issued upon completion. Due to constraints of space and logistics, the UniFAST Secretariat has been advised that only the Presidents/Head of Institutions will be allowed to attend the actual ceremony as the principal signatory of the MOA.
