Subject: **APPROVAL OF THE SIGNING CEREMONY ON THE MEMORANDUM OF AGREEMENT BETWEEN THE COMMISSION ON HIGHER EDUCATION – UNIFIED STUDENT FINANCIAL ASSISTANCE SYSTEM FOR TERTIARY EDUCATION AND PRIVATE HIGHER EDUCATION INSTITUTIONS (HEIs) WHOSE ENROLLED STUDENTS ARE SELECTED AS TERTIARY EDUCATION SUBSIDY (TES) GRANTEES OR AVAIL OF THE STUDENT LOAN PROGRAM UNDER RA 10931**

Date : 3 December 2018

During the **17<sup>th</sup> UniFAST Governing Board Meeting** on **November 20, 2018** held at the Chair's Conference Room, 4/F HEDF Bldg., C.P Garcia, Diliman, Quezon City, and upon recommendation of the UniFAST Secretariat, the body led by **Dr. J. Prospero E. De Vera III**, Chairman of the Commission on Higher Education and the UniFAST Governing Board approved the **lists of qualified TES beneficiaries enrolled in Private HEIs located in cities or municipalities with no SUCs and CHED-recognized LUCs and those students enrolled in various Private HEIs, SUCs and CHED-Recognized LUCs who belong to the poorest of the poor, poor and near poor households (Listahanan 2.0)** identified by the Department of Social Work and Development.



In view of this development, **Chairman De Vera III** approved the holding of the **Signing Ceremony on the Memorandum of Agreement (MOA) between the Commission on Higher Education – Unified Student Financial Assistance System for Tertiary Education and Private Higher Education Institutions** whose enrolled students are selected as Tertiary Education Subsidy (TES) Grantees or who intend to avail of the Student Loan Program (SLP) under RA 10931.

The UniFAST Secretariat cordially invites you to attend the **Official Signing Ceremony on Monday, December 17, 2018 which will be held at the UP Bahay ng Alumni, Diliman, Quezon City**, in two (2) batches as follows:

1. **9:00AM - 11:00AM - Visayas and Mindanao Private HEIs**
2. **2:00PM - 4:00PM - Luzon Private HEIs**

The signing of the MOAs is in accordance with the mandate of RA 10931 and its Implementing Rules and Regulations approved by the UniFAST Governing Board on February 22, 2018 in order to facilitate the disbursement of funds to Private Higher Education Institutions whose enrolled students will avail of the TES and SLP Programs under RA 10931. The Program for this momentous activity will be emailed/sent to you upon its completion.
